We convened the Financial Literacy Roundtable with leaders like Willie Spears and Jannease Seastrunk of Red River Bank, Scott Newcomer of Bancorp South, Derick Vance of Regions Bank, and Willie Watson of Mid South Bank to change lives for the better in Cenla.

For one thing, we're offering a terrific workshop for area case managers that was developed by the Consumer Financial Protection Bureau. It's entitled "Your Money, Your Goals: A Financial Empowerment Toolkit for Social Services Programs." The idea is that every day, staff at many of our area nonprofits sit down with folks who've come in for help. Often financial issues lie at the root of the problems, but few of us get training in how to address those issues.

This workshop, to be offered twice (March 12 and March 19) will provide first-rate training for up to 50 local case managers so that they can help their clients more effectively and see more results from their work. If you're interested, contact me at britt@unitedwaycenla.org.

The Roundtable is also working with other partners to explore ways to create more affordable housing here. The statistics show that we don't have enough, at least enough affordable housing that's clean and decent.

PARTNER AGENCY SPOTLIGHT



The Rapides Children's Advocacy Center, Central Louisiana's non-profit agency dedicated to helping abused and neglected children in our community, announced the expansion of the CASA program to Avoyelles Parish.

12th Judicial District Judge Bill Bennett stated, "Judge Spruill and I are very excited about the return of the CASA program and CASA volunteers to Avoyelles Parish. These volunteers provide comfort and support to young children in need of care." Judge Bennett added, "Our previous experience with CASA proved very beneficial to the children and to the Juvenile Justice System. We look forward again to working with them to help make the lives of children in need of care better."

The goal of CASA (Court Appointed Special Advocates) is to recruit and train community volunteers to advocate



on behalf of abused and neglected children in court. The addition of CASA in this parish is due to the collaborative efforts of the 12th Judicial District Court, Louisiana Supreme Court, CASA Assistance Program, Louisiana Department of Children and Family Services, and residents of Avoyelles. By incorporating CASA as a tool in the Avoyelles foster care system, children will spend less time in foster care and are more likely to be adopted.

Wade Bond, Executive Director of the agency, stated, "Providing advocacy to the children of Avoyelles Parish is crucial to accomplishing our vision of eradicating the cycle of abuse and neglect." Bond added, "We are looking forward to creating a lasting partnership with the residents of Avoyelles, the court officials and state agencies, as we work together to help heal and champion abused and neglected children throughout Central Louisiana."
